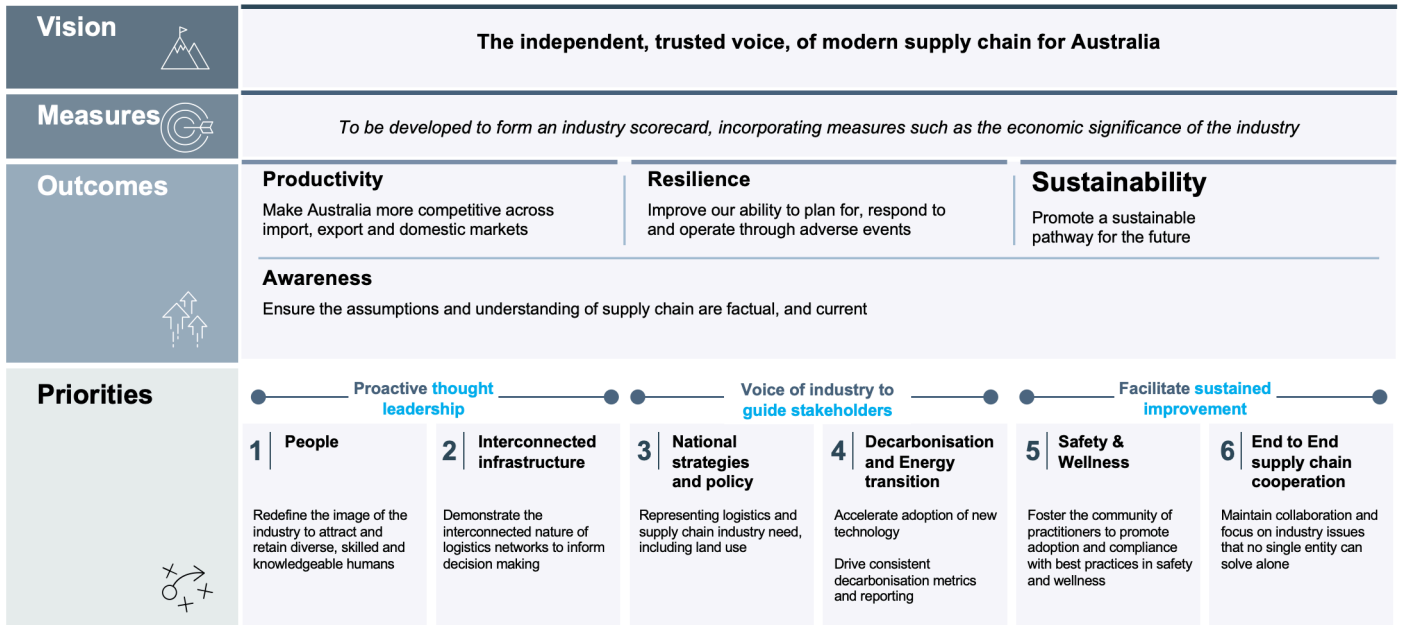

Some of the ALC's recent achievements and contributions include:

- **National Freight and Supply Chain Strategy:** Led the push for a review of the National Freight and Supply Chain Strategy and coordinated nationwide workshops to gather the single most informed industry viewpoint to be included in the official submission to the Review.
- **Heavy Vehicle National Law Review:** Participated in both the review process conducted by the National Transport Commission, the subsequent National Heavy Vehicle Law Industry Engagement process led by Mr. Ken Kanofski and actively participating on the Reform Advisory Committee which spearheaded the recent width increase for heavy vehicles on Australian roads.
- **House of Representatives Standing Committee on Regional Development, Infrastructure and Transport:** In addition to a written submission provided to the review, ALC also appeared in front of the Standing Committee for the Inquiry into the Implications of Severe Weather Events on the National Regional, Rural, and Remote Road Network, stressing the importance of a national approach to emergency response and creating supply chain resilience.
- **Transport for NSW Hearing into the Tolling:** In addition to a written submission provided to the review, ALC also participated in the hearing for the NSW Tolling Review and demand careful consideration of the interests of all stakeholders, including freight operators, freight owners, consumers, and the broader public. ALC stressed that transparent tolling practices, fair pricing principles, and equitable cost allocation are vital for maintaining a balanced and sustainable freight transport and supply chain system.

- **Security Legislation Amendment (Critical Infrastructure) Bill 2021:** Successfully negotiated a reduced list of Critical Infrastructure Assets (49 to 13) and a revised asset services definition, significantly reducing the regulatory impost on business. The Australian Parliament passed this legislation earlier this year and the ALC engaged quickly and proactively in the interest of members, to improve the outcomes for the sector.
- **Independent Review into Commonwealth Disaster Funding:** Participated in the Australian Governments independent review of Commonwealth Disaster Funding and stressed the importance of a coordinated, strategic approach that supports wellbeing, national productivity, prosperity, and economic security in the context of projected increase in natural disasters over the coming decades.
- **National Hydrogen Strategy:** Submitted a brief into the National Hydrogen Strategy outlining industry support for hydrogen programs so that Australian hydrogen is available for use in various applications including transport applications. ALC stressed that it is somewhat premature to mandate targets to encourage the uptake of hydrogen powered transport units.
- **Employment White Paper:** Submitted a brief to the Department of Treasury for the Employment White Paper. ALC emphasised that to overcome the skills and labour shortages in Australia will require a holistic approach, creating policy solutions that consider skills development, participation, and migration. This approach will need to be underpinned by industry engagement to identify current and future labour demands and skills as well as to identify gaps in current education offerings, funding and immigration policy.
- **Delivery curfews:** Ongoing advocacy efforts, supported by comprehensive community research, saw the NSW Government announce that it would move to permanently lift curfews in industrial and business zones in 2022 as part of a package of COVID-related reforms. Other states have extended their temporary arrangements and ALC continues to push for permanent change.
- **Heavy Vehicle National Law Review:** Participated in both the review process conducted by the National Transport Commission, the subsequent National Heavy Vehicle Law Industry Engagement process led by Mr. Ken Kanofski and actively participating on the Reform Advisory Committee which spearheaded the recent width increase for Heavy vehicles on Australian roads.
- **Inland Rail:** In addition to a written submission provided to the review, ALC also participated in a ministerial roundtable to consider a possible location for the Melbourne intermodal terminal associated with the Inland Rail project.
- **Review of Infrastructure Australia:** Submitted a brief to the independent review of Infrastructure Australia (IA) which highlighted the need for a whole-of-economy view in infrastructure planning. The ALC stressed the importance of IA's role in providing specialist advice to ensure that the returns to the taxpayer on infrastructure investments are maximised.
- **Micro-mobility Report:** Collaborated with Uber on the development of a comprehensive report that examined the challenges and opportunities of last mile deliveries in dense urban environments.
- **Productivity Commission Review into Maritime Systems:** Consulted with the Productivity Commissioner, Professor Stephen King, and members of the Commission Secretariat as part of Productivity Commission review of maritime systems.
- **Extreme weather events:** Supported communication and coordination with industry and governments on extreme weather events including convening a daily status update with Transport for NSW on the recent flood emergencies and participated in the Parliamentary National Emergency Preparedness Summit in Canberra 2023.
- **Release of Delivering Freight Decarbonisation:** ALC's Sustainability Committee collaborated with Climateworks on the development of a comprehensive report that outlined national strategies for reducing Australia's transport emissions.
- **Federal Budget:** ALC continued to push for critical infrastructure investment particularly in intermodals and we were pleased to see the multi-billion investment from the Australian Government's to the development of two intermodal freight terminals in Melbourne to facilitate improved connectivity between the Inland Rail and the Port of Melbourne.
- **Events and Media:**
 - Delivered key major events including the ALC Supply Chain Summit, safety webinars, the ALC Technology Summit, the Annual ALC-Government Dialogue as well as a number of Ministerial Business Delegations and Ministerial events.

- Maintained regular engagement with Australian Government agencies through the Office of Supply Chain Resilience, TISN, Home Affairs' Cyber and Infrastructure Security Centre and multiple State and Territory Government freight and logistics councils.
- Supporting affiliate industry events, the ALC recently participated in the Victorian Government's Freight Decarbonisation Summit, the Sydney Tolling Review and Defence's National Resilience Conference.
- Worked with The Australian newspaper to produce the first Logistics Special Report published in 2021, 2022 and 2023.
