Executive Insight : Reflections and Priorities from September 2024

From the Desk of Dr Hermione Parsons, ALC CEO & Managing Director

In September we continued our efforts to be in all the right places, championing our members and driving the ALC's strategic priorities in Canberra and across Queensland and NSW.

The NSW Freight Reform Panel is committed to a complex systems analysis guiding recommendations for the reform process for NSW's freight logistics chains. The NSW Freight Policy Reform: Interim Directions Paper was released last week with the final consultation ending October 23. The panel received over 120 submissions for the first stage of consultation. Please share your views on the final Directions Paper including any gaps. These are complex issues, and your expert advice is appreciated.

At the invitation of Senator Glenn Sterle, the ALC attended the National Road Transport Safety Roundtable at Parliament House, Canberra, with approximately 20 industry leaders, the importance of which was endorsed by an address from Prime Minister Anthony Albanese.

Our industry provides an essential service in times of crisis and calm, yet critical workforce issues continue with inadequate training and fragmented driver licensing, an escalation of road safety incidents, and the persistent challenge of attracting workers to the industry. At this roundtable we agreed to advocate together to take these issues to National Cabinet.

This month's ALC Council involved a presentation and detailed discussion with Joe Buffone PSM, Deputy Coordinator National Emergency Management Agency (NEMA) on national supply chain resilience and civilian supply chain fuel issues.

The session was followed by a tour of NEMA's National Situation Room.

The Council meeting also featured ALC Councillors Darren Searle (ESR), Saski Groen In't Woud (Pacific National) and Neil Stephens (Port of Brisbane) sharing their perspectives on the Barriers to Infrastructure Investment. The meeting concluded the private sector is ready to invest, but regulatory hurdles and policy inconsistencies delay progress. Industrial land shortages, high costs, and poor urban planning were also identified as key issues. Solutions included retaining and expanding industrial land, allowing higher density logistics development, and securing critical utilities. These messages were taken to Parliament House Canberra, to discuss with parliamentarians at our evening event.

In partnership with Healthy Heads in Trucks and Sheds we organised a Parliamentary Friendship Group evening event in Parliament House, Canberra. Presided over by Hon Nola Marino MO, Senator Glenn Sterle, Senator Anthony Chisholm and Senator Bridget McKenzie, issues of workforce shortages and the need for basic amenities at truck driver rest area's across the country remained the focus, with drivers outlining deplorable conditions. Approved funds need to flow to ensure we, as a country, uphold the values of civilised society.

The ALC participated in NEMA's High Risk Weather Season National Preparedness Summit in Canberra, which focussed on responses to and recovery from catastrophic crisis events. Crisis management specialists from Australian governments, the private sector and community organisations were included in this detailed exercise exploring how we prepare for, respond to and recover from disasters as a nation.

18-19 September - NEMA National Preparedness: Higher Risk Weather Season Summit 2024

ALC Leadership and Members attended the <u>NEMA National Preparedness - Higher Risk Weather Season</u> (<u>HRWS</u>) <u>Summit in Canberra</u>, an essential event focused on enhancing Australia's readiness, response, and recovery to natural disasters and catastrophic events—critical issues that directly impact the logistics and supply chain sector.

NEMA's annual HRWS Summit brought together leaders from across the nation, and our CEO, Dr Hermione Parsons, was right there, participating alongside government, private, and not-for-profit sector experts.
