From the Desk of Dr Hermione Parsons, ALC CEO & Managing Director

The ALC's membership in the National Fuel Council remains focused on tackling the pressing issue of fuel security—a longstanding challenge for our industry. We're proud to play an active role in shaping

solutions for this critical matter.

The NSW Freight Policy Reform Program has wrapped up its final consultation process, with the panel now hard at work drafting recommendations. It's been heartening to see the industry's positive feedback throughout this journey. Yet, building supply chain awareness across all levels of government remains a significant hurdle.

It was a pleasure catching up with Philip Davies, ALC's former Independent Chair and now ALC Fellow. Phil's unwavering passion for championing supply chain systems and infrastructure continues to inspire.

We're thrilled by the success of the Wayfinder Freight Heartland Tours trial, which showcases the exciting career opportunities in supply chain for women. The ATN article offers a fantastic update on this initiative.

Collaboration remains key, as highlighted by our meeting with NSW Minister Jo Haylen's Freight Transport Advisory Council. Together with Marika Calfas (CEO, NSW Ports) and Greg Walls (NSW Ports), we took the critical shortage of industrial land in Sydney to the Secretary of NSW Treasury, outlining its economic consequences. These discussions are vital to driving change.

Our Q4 ALC Board and Council meetings were hosted at Accenture's stunning Barangaroo offices, where we got a fascinating tour of their Al Lab. Industry News Truck Drivers being identified in 2024 Occupation Shortage List



The 2024 Occupation Shortage List (OSL) has been released, spotlighting critical roles facing recruitment challenges across Australia. Truck drivers rank as the fourth most undersupplied role, emphasizing the urgent talent shortage in this essential sector.

The OSL, subject to government approval, is set to replace the current Skilled Migration Occupation List—a transition ALC has strongly supported during the recent ABS ANZSCO review.

Policy Submission

ALC Submission to the Paraffinic Diesel Standard Consultation

The Australian Logistics Council has made a submission to the Paraffinic Diesel Standard Consultation, endorsing the proposed establishment of a national paraffinic diesel standard to advance environmental performance and fuel quality in Australia. The ALC's submission emphasises the importance of aligning with the European EN 15940 standard, recommending stricter sulphur limits and mandatory quality controls for fuel blends. To support fuel integrity, the ALC advocates for transparent labelling, rigorous certification processes, and economic incentives to promote renewable fuel use. Drawing on lessons from past fuel regulations, the ALC underscores the need for a robust framework that will ensure sustainable emissions reductions while fostering industry innovation across the supply chain.

ALC Backs National Heavy Vehicle Law Amendments to Boost Productivity

The Australian Logistics Council has endorsed the National Heavy Vehicle Law (NHVL) Amendment Bill, recognising its potential to improve safety, productivity, and sustainability in the logistics sector. Key reforms, including the National Audit Standard (NAS), vehicle mass and size increases, and accreditation changes, are supported for their potential to streamline operations, reduce emissions, and boost compliance. ALC also advocates for infrastructure upgrades to support heavier vehicles, strategies to address workforce challenges and incentives for operators to upgrade fleets to sustainable fuel sources. The ALC supports these reforms and views them as essential to enhancing Australia's logistics network and is committed to ensuring their successful implementation.

SA Transport Strategy

The Australian Logistics Council is preparing its submission in response to South Australia's 30-Year Transport Strategy, which outlines ambitious goals for connectivity, sustainability, and resilience across the state's transport network. As we draft our response, the ALC seeks member feedback on specific areas, including freight infrastructure commitments, alignment with national logistics policies, and zoning for industrial land near key logistics hubs.
